Founded in 1990, Access Justice Brooklyn is an independent 501(c)(3) organization that provides high-quality, pro bono legal services and community education to our neighbors in need. Using the collective talents of our dedicated staff and volunteers, we help ensure a more accessible legal system and equitable Brooklyn. Our approach involves recruiting, training, and mentoring pro bono volunteers from a range of legal backgrounds – a proven service model that we pioneered and have maintained since our founding. Central to achieving our mission, this partnership with pro bono volunteers allows us to assist far more individuals than we could alone and gives us critical flexibility to address new legal issues as they emerge. The success of this model is evidenced by the positive results we achieve for thousands of Brooklynites each year: stabilizing custody, visitation and support obligations, obtaining divorces, addressing end of life issues, obtaining Article 17A guardianship, preventing foreclosure and negotiating loan modifications, and halting or reducing debt collection. Last year our services benefitted over 12,200 individuals and families, made possible through the support of 204 pro bono attorneys and other volunteers who collectively donated over 5,520 hours of legal assistance to the Brooklyn community.
